Approved Amendment 10-A to the Constitution: vote – yes 186; no 107; abstained 2.

Approved to form an Administrative Commission to dissolve Clio.

Approved examinations of: Ms. Sue Richardson Moore, ready to serve as Lay Pastor & Mr. William Rountree, commissioned as Lay Pastor at Flat Rock (Mt. Airy).

Approved Candidates ready to receive a call: Grier Booker Richards & Nicholas C. Nielson.

Accepted withdrawal as Candidate: Alex Hudson, effective Jan. 1, 2011.
